Susan's Story...

Susan is a college educated, single mom of two boys from a supportive family. She began experimenting with alcohol at age 15, using Oxycontin at age 21, and was addicted to Heroin by age 24. Her disease quickly led her to places she never thought she would go—loss of custody of children, stealing, totaling vehicles, living on the run, lying and using drugs during pregnancy. Her life spiraled out of control for nearly 10 years, damaging all of her family relationships, her friendships, her job, and her health.

After repeated failures in other programs that don't use Suboxone, and facing termination of parental rights, Susan began participating in treatment at Transitions. She was "sick and tired of being sick and tired." Susan began MAT treatment with Suboxone in combination with psychosocial counseling and education. The use of Suboxone as part of her treatment changed everything about her recovery. She was able to concentrate, learn about her disease, successfully overcome her cravings and actually feel better. Susan was no longer completely preoccupied with using drugs.

Today, Susan has completed residential treatment and is participating in outpatient. She is employed, she keeps her commitments, she is active in a 12 Step program, owns a car, has money in the bank, and perhaps most importantly, is on track to regain custody of her children soon. She is working on earning the trust of her family and friends, and day by day, with the appropriate resources, she is living a life of gratitude and recovery.

A Growing Crisis

The last decade has seen a new culprit leading the pack of mood altering substances—opioid narcotics. There has been a sharp and dramatic rise in the misuse of both prescription and illicit opiates for the last 10 years. "Opiates" include Heroin and the following commonly misused prescription painkillers: Vicodin, Lortab, Lorcet, Percocet, Roxicet, Methadone, Opana, Hydrocodone, Oxycontin and Oxycodone.

Accidental overdoses from opiates is the *leading cause of death in 18-25 year olds*, more than motor vehicle deaths and suicides combined. In all age groups, accidental overdoses account for more deaths than motor vehicle deaths.

Northern Kentucky has the highest rate of illicit drug use in the state while Cincinnati has the second highest rate in Ohio. By self-report, Transitions, Inc., sees 80 percent of detox admissions seeking treatment for opioid and/or Heroin addiction.

What is Suboxone?

Suboxone is a medication used as an adjunct to treat individuals with opioid addiction, with the intent of improving treatment outcomes. This medicine is <u>not</u> the treatment for the disease of addiction, but rather decreases relapse rates and improves cognitive function so treatment can be more effective. Without Suboxone, brain recovery can take up to a year for most function to return, and 3-5 years for the brain to completely recovery.

Suboxone limits the symptoms of physical withdrawal, *stops the psychological cravings* and "normalizes" brain function.

These effects result in markedly decreased relapse rates so individuals can productively participate in counseling, twelve-step programs and other psychosocial treatments to get their disease into remission. Because it also acts as a blocker, *patients cannot get high on opioids while taking Suboxone*.

Our Approach

Transitions, Inc. offers a comprehensive treatment approach including the use of Suboxone combined with psychosocial counseling and education. Numerous federally funded, Substance Abuse Mental Health Services Administration sponsored studies show substantially improved outcomes when using Suboxone as part of a comprehensive treatment approach.

Transitions, Inc. offers MAT utilizing Suboxone *in combination with* treatment services.

Individual treatment plans are prepared for each patient and reviewed regularly with treatment staff and the Medical Director. A patient using MAT with Suboxone is required to fully participate in the recommended level of treatment services which may include some or all of the following: detox, outpatient, residential, recovery support meeting attendance, and aftercare services.
